## WAIVER, RELEASE OF ALL CLAIMS AND HOLD HARMLESS AGREEMENT FOR THE NIPPERSINK MIDDLE SCHOOL PTO

Please, read this form carefully and be aware that in signing up and participating in Nippersink Middle School PTO activities, you will be waiving and releasing all claims for injuries arising out of the programs, that you or the other named participants might sustain. The terms "I", "me", and "my" also refer to parents or guardians as well as participants in the programs. In registering for these programs, you are agreeing as follows:
